AGENDA TOPIC: Fiscal Year 2013-14 Financial Analysis of Benchmark Institutions

BACKGROUND: Annually, Intercollegiate Athletics provides a financial analysis comparison to our athletic peers.

SUMMARY AND ANALYSIS:

Source of all information: Office of Postsecondary Education – Equity in Athletics Data Analysis website and the MVFC and HL summary of the NCAA Financial Reports.

Expenditures - Missouri Valley Conference

- The MVFC figures include MVFC institutions that also compete in the Missouri Valley Conference in basketball. The football expense figures are for the three benchmark institutions of Illinois State, Northern Iowa, and Southern Illinois.
- The total expenses Men's and Women's Basketball ranks the lowest.
- YSU ranks second to lowest in total overall expenditures (Indiana State).
- The average expenditure on women's basketball is more than we spend on men's basketball.

Expenditures – Mid-American Conference

- Our total expenses for all four categories rank the lowest.
- Since 2003-04, the average rate of growth of total expenditures for the MAC institutions are growing at an annual rate of nearly \$500,000 per year faster than our growth. Therefore, the gap between us and them continues to grow.

Expenditures - Horizon League

- Our total expenditures of \$14,385,066 include the \$3,779,330 in football expenditures. We are the only institution in this peer group that sponsors scholarship football.
- The column titled "League Sponsored Sports" identifies total expenditures (noted in the column directly to the left) less expenditures spent on sport programs not sponsored by the Horizon League (football for us) and administrative or unallocated expenditures.
- Once again, our investment in men's basketball is less than our peers investment in women's basketball.

Revenues - Missouri Valley Football Conference

- YSU generates \$1,860,602 in revenue from football compared to the conference average of \$1,252,900.
- YSU generates 49% of the revenue needed to operate the football program compared to the conference average of 33%.

Revenues - Horizon League - Men's Basketball

- The average investment made by league institutions (above income generated by the men's basketball program) is nearly double that made by Youngstown State.
- YSU generates 39% of the revenue currently needed to operate the men's basketball program which is higher than the league average of 32%.
- It is important to remember that YSU is the only institution in the Horizon League that sponsors scholarship football. Therefore, a significant amount of revenue that would otherwise be directed to the men's basketball program (sponsorships and ticket sales) is allocated to the football program.

Revenues - Horizon League - Total

- YSU generated \$4,299,145 in athletically related revenue compared to the league average of \$3,199,057. This figure represents the highest total revenue figure in the league.
- YSU generates the highest total income from athletically related activities and expends the second lowest when removing non-Horizon League sponsored programs (Green Bay).
